

Caltex – ‘You Choose the Date’ 10 cent per litre AA Smartfuel discount campaign terms and conditions

Campaign summary: Caltex is giving AA Smartfuel cardholders and AA Members the opportunity to choose (once only) which day they want to earn 10 cents per litre of AA Smartfuel discounts between Tuesday 29 August 2017 and Thursday 31 August 2017. Customers must spend \$40 or more on petrol or diesel in one transaction at a participating Caltex station during the campaign period and swipe their AA Membership or AA Smartfuel card to be eligible.

The promoter is Z Energy 2015 Limited, Box 684, Auckland, 1140, New Zealand, the company that markets the Caltex brand in New Zealand, under license from Chevron Inc. which owns the Caltex logo and Caltex trademarks. For the purposes of these terms and conditions Z Energy 2015 Limited is referred to as “Caltex NZ”.

1. The ‘You Choose The Date’ campaign runs from 12:00:00 am on Tuesday 29 August 2017 to 11:59:59 pm on Thursday 31 August 2017 (campaign period).
2. The 10 cent per litre You Choose The Date AA Smartfuel discount offer is available once only during the campaign period but only on your next visit to Caltex.
3. To earn the 10 cent per litre customers need to:
 - a. Visit a participating Caltex station* within the trading hours of each individual station from 12:00:00 am on Tuesday 29 August 2017 to 11:59:59 pm Thursday 31 August 2017 (list of participating Caltex stations [here](#));
 - b. Spend \$40 or more on petrol or diesel in one transaction (qualifying purchase). Qualifying purchases may be made by cash, eftpos, credit card, or StarCash.
 - c. Swipe their AA Membership or AA Smartfuel card
4. Standard AA Smartfuel terms and conditions apply to all AA Smartfuel discounts, including but not limited to the 50 litre maximum and expiry dates. Visit AAsmartfuel.co.nz for full terms and conditions.
